ENTRY AGREEMENT

By entering and signing this entry blank as Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the rules of this competition.

I agree to be bound by the rules of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, their officials, directors and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered.

I also agree that as a condition of and in consideration of acceptance of entry, the competition may use or assign photographs, videos, audios, cablecasts or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport or the UPHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize an amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation.

RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION

(This document waives important legal rights. Read it carefully before signing)

I AGREE in consideration for my participation in the Competition Oshkosh Charity Horse Show to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaultor, longeur, lessee, owner, agent, coach, trainer or as parent or guardian of a junior exhibitor (age 18 & Under). I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release and hold harmless the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, for the negligence of the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I UNDERSTAND that I am entitled to wear protective equipment without penalty, and I acknowledge that the Competition strongly encourages me to do so while

WARNING that no protective equipment can guard against all injuries.

If I am a parent of guardian of a junior exhibitor (age 18 & Under), I consent to the child's

participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that the Competition as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

Equine Sports Council every entry at a show that pays the Equine Sports Council exhibition fee and is exhibited and judged according to the ESC rules and guidelines shall constitute an agreement and affirmation that: (1) the owner, agent, lessee, trainer, manager, coach, driver and rider and any of his/her representatives are bound by the show rules; (2) that every horse, rider, and/or driver is eligible as entered; (3) they agree to accept as final the decision of show management on any question arising under said rules, and agree to hold the show, equine sports council, their officials, directors, and employees harmless for any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold the show, equine sports council, and their officials, directors, employees and agents harmless for any injury or loss suffered during or in conjunction with the show, whether or not such injury or loss resulted directly or indirectly from the negligent acts or omissions of said officials, directors, employees or agents of the show or equine sports council.
